Tournament Info and Fees

A minimum of 24 golfers constitutes a tournament and are eligible for our tournament & meal package pricing.

Groups from 24 to 40 people will be tee times. Groups over 40 people will be shot gun start. You can choose your Shot Gun start time from the following: 10:00am, 11:00am, 12:00pm (noon) or 1:00pm.

The following Tournament Fees are only applicable when including the meal option in your tournament.

18 Hole Tournament

Groups up to 40 people will be tee times. Groups over 40 people will be shot gun start.

Weekday Pricing (Monday – Thursday): \$51 per person, plus GST & PST

Weekend Pricing (Friday – Sunday): \$59 per person, plus GST & PST

9 Hole Tournament

Groups up to 40 people will be tee times. Groups over 40 people will be shot gun start.

Any Day Pricing: \$40 per person, plus GST & PST

Please note, each price includes the cost of a green fee and power cart

Deposit

A non – refundable \$500.00 deposit is required at the time of booking to ensure your tournament date. This deposit will be credited towards your final bill following the completion of your tournament.

Full Payment/Numbers of Golfers

An estimate of the number of golfers and banquet guests are required at the time of booking. Please confirm your final numbers **one week** prior to your tournament date. The cost of the tournament will be based on the final numbers provided. Final payment of tournament costs are due on the date of your tournament prior to your start time. Account billing may be arranged in special circumstances.



Cancellation

The tournament will proceed as scheduled, unless the course is deemed unplayable by Harbor Golf Club and Resort. At which point, tournament green fees and carts costs will be refunded. The banquet portion (if applicable) will proceed regardless of inclement weather.

Tournaments cancelled within 7 days of the Tournament will forfeit FULL deposit and pay 50% of tournament fee and banquet costs based on the original estimated numbers provided. Cancellations 8 to 30 days prior to the tournament will forfeit their FULL deposit; 31 to 60 days will forfeit 50% of deposit; more than 60 days prior will receive full refund on deposit.

Liability

The tournament organizer is responsible for any damage to golf course, golf carts, rental clubs or clubhouse.

Harbor Golf Club and Resort assumes no responsibility for the loss of personal property.

Sask Liquor/Drug Regulations & Consumption Public Places

Harbor Golf Club and Resort is a licensed premises and therefore will be the sole supplier of food and beverage items. It is prohibited to bring personal alcoholic beverages onto the premises, including the parking lot. Any alcoholic beverages must be purchased in the clubhouse or from the courtesy cart. Violators will be removed from the premises with no refund.

**It is illegal to consume cannabis in a public place. If Harbor Staff encounters a customer consuming cannabis, they will contact the RCMP for enforcement. **

Responsible Beverage Service

The staff and management at Harbor Golf Club & Resort are committed to the safety of all of our patrons. We encourage alternate transportation be arranged for your event for those participants who will be consuming alcoholic beverages. The staff and management have the right to refuse serving individuals alcohol.

Proximity Markers and Special Holes

Any special requests for “Long Drive”, “Closest to the Pin”, “Closest to the Line” or other special competitions must be supplied to the Pro Shop one week prior to your tournament date. Harbor Golf staff will place proximity signs on designated holes.

Signage and Sponsorship

The tournament organizer is responsible for putting up and taking down of any specific signage or sponsorship signs that are associated with your tournament. Harbor Golf will provide power carts/club car to assist you in placing the signage on the course prior to the tournament.



General Rules

It is the responsibility of the group representative to provide all rules to participants and that they be followed throughout the tournament day.

The Course Marshall's instructions shall be adhered to strictly. The Marshall has the authority to ask players/teams to pick up their ball and move to the next hole. Failure to comply with the Marshall's instructions or any rude behavior can result in removal of player(s) from the golf course.

Players must play with their own set of clubs. Rental sets are available through the pro-shop.

Golf carts MUST BE kept clear of all tees and greens.

A maximum of two (2) persons per power cart.
