2026 TOURNAMENT REQUIREMENTS & FEES

- A minimum of 24 golfers constitutes a tournament to be eligible for our tournament and meal package pricing.
- VIP tee times are available for groups of 8 to 24 golfers with advance bookings. Please note that in the event of a large tournament booking on your day, you will be contacted with a choice of rescheduling or to be smoothly incorporated into the tournament.
- Tournaments ranging from 24 to 59 people may need to be scheduled as tee times pending course availability. Shotguns are available Mon/Tue for groups less than 60.
- Groups over 60 people may have a “shot gun” start. You can request your “shot gun” start time from the following: 9:00 am, 10:00 am or 1:00 pm pending course availability
- Early Bird Bookings, with deposits received prior to April 1, 2026, will receive 10% off both golf and banquet pricing, and all regularly priced ProShop items. Also, 4 x 2026 18 hole w/cart gift certificates for raffle or gifts will be awarded.

The following Tournament Golf Fees are 18 holes per person with cart*, and applicable when including a meal option with your tournament package. “Golf Only” Tournaments (*without onsite meal*), will be subject to a 15% price increase. *5 % Gratuity, GST & PST will be added to golf/cart pricing.*

PROXIMITY MARKERS & SPECIAL HOLES

Requests for “Long Drive”, “Closest to the Pin”, “Closest to the Line” or other special competitions must be supplied to the Pro Shop one week prior to your tournament date. Harbor Golf staff will place proximity signs and draw lines on designated holes. If we do not receive confirmation of contest markers, Harbor Golf staff will place at their discretion. Our Suggestions:

- Hole in One - #8 or #11
- Closest to the Pins – #11 for Men and #4 for Ladies
- Longest Drive - Men - #2 or #7, Ladies #2 or #17
- Longest Putt - #9 and/or #18



SIGNAGE & SPONSORSHIP

Harbor Golf staff will put up and take down any specific signage or sponsorship signs that are associated with your tournament. Your organizer must have signage available a minimum of 2 hours prior to the tournament start time, along with any specific placements.

- Best holes for large displays - along the road #6, #9, #13, #18
- Water / Power Requirements - #10

GENERAL RULES

1. It is the responsibility of the group representative / tournament organizer to provide all rules to participants in a timely manner and that they be followed throughout the tournament day.
2. The Course Marshall's instructions shall be adhered to strictly. The Marshall has the authority to ask players / teams to pick up their ball and move to the next hole. Failure to comply with instructions, or any rude behaviour, can result in the removal of player(s) from the property.
3. Pace of Play is 5.0 hours for tournaments, “Own the Course” options may be negotiated.
4. Each player must have their own set of clubs. Rental sets are available through the pro-shop at a rate of \$20 - \$50 plus taxes.
5. Golf carts MUST BE kept clear of all tee-off areas and greens. A maximum of two (2) persons per power cart.
6. Alcohol purchases and consumption may begin after 9:30 AM.
7. Start Time - all golfers are requested to be in their assigned carts no less than 15 minutes prior to the shotgun time, to receive instruction from tournament organizer and Harbor Golf representative. If a banquet meal is arranged after the golf portion, concession and beverage cart services will end approximately ½ hour prior to the start of your banquet. If the tournament organizer requests a strict mealtime – e.g.) 5 pm with a noon shotgun, it will be communicated with golfers at the announcement speech and from on-course marshaling to help keep pace of play.

DRESS CODE

- Shirts, golf shoes or running shoes required (no cowboy boots etc.)
- No torn or tattered jeans, short shorts or swim wear.

MEAL PLANNING & GRATUITY

We are pleased to offer the following options for your Tournament Banquet. Menu planning can be customized for dietary restrictions; however, prices may be adjusted by adding up to \$5 per request. *Prices are per person.*

BREAKFAST BUFFETS (including Coffee & Tea)

Breakfast options are available prior to the tournament for players if requested. This is highly recommended for tournaments with over 60 players with a shotgun starting at 10 AM. The cost of a breakfast option starts at \$17/ person, is a buffet style and must have a guaranteed number. You may also request breakfast sandwiches be available at the concession. All breakfast options must be pre-ordered with a guaranteed number and added to your invoice.

SLGA LIQUOR / DRUG REGULATIONS & CONSUMPTION PUBLIC PLACES

Harbor Golf Club is a licensed premises and therefore will be the sole supplier of food and beverage items. **It is prohibited to bring personal alcoholic beverages onto the premises, including the parking lot.** Any alcoholic beverages must be purchased from the clubhouse, concession, or from the beer cart starting at 9:30 AM. Violators will be removed from premises with no refund. ***Harbor staff may ask to view inside of your cooler or golf bag contents as confirmation.***

If you wish to have a sponsor serve alcohol at your event, all alcohol must be purchased from Harbor Golf and adhere to SLGA regulations. Details must be confirmed a minimum of 1 month prior to your event to ensure inventory. Please request this specific SLGA information if it applies to your tournament.

****It is illegal to consume cannabis in a public place. If Harbor Staff encounters a customer consuming cannabis, they are instructed to contact the RCMP for enforcement. ****

It is the responsibility of your event organizer to arrange transportation for any affected persons

RESPONSIBLE BEVERAGE SERVICE

The staff and management at Harbor Golf Club are committed to the safety of all of our patrons. We encourage alternate transportation to be arranged for your event for those participants who will be consuming alcoholic beverages. The staff and management have the right to refuse the service of alcohol to inebriated or difficult individuals. **The staff and management have the authority to stop bar service to the entire event if issues arise from alcohol consumption.**

In an effort to care of our guests and our staff, it is important for us to implement a policy regarding alcohol service and when to terminate the service of alcohol in accordance with the Saskatchewan Liquor Laws and "Serving It Right" regulations.

The first step is to make you, the organizer of the event, aware that this policy is in place. It is the responsibility of the tournament coordinator to let all patrons know that if alcohol service is to be terminated, this is the process.

Step 1: Organizer to sign off on the package, acknowledging that the policy has been noticed and will be adhered to in the agreement at the end of this document.

Step 2: If a guest or group of guests need to be discontinued from the service of alcohol, it will be the responsibility of the on-duty Harbor manager and your event organizer to discreetly inform the individual or group of these decisions.

Step 3: If the group or individual does not comply with this decision, it will be the combined responsibility of your event organizer, the on-duty Harbor manager, and possibly the RCMP, to escort / remove guests from the facility and ensure safe transportation.

DEPOSIT

A non – refundable \$2000.00 deposit is required at the time of booking to ensure your tournament date. (VIP Groups must secure their advance booking with a credit card.) This deposit will be credited towards your final bill following the completion of your tournament. Tournaments may be rescheduled without penalty within the same season and with more than 2 weeks of notice. *If you cancel and do not rebook within the same year with an early bird price, you will forfeit your deposit.*

FULL PAYMENT / NUMBERS OF GOLFERS

An estimate number of golfers and banquet guests are required at the time of booking. Please confirm your final numbers two (2) weeks prior to your tournament date. *An increase in numbers after this time will be considered and approved by the Course Operations Manager.* You will be billed based on your guaranteed numbers or actual number of guests if they are higher than the guaranteed number. Final payment of your tournament invoice is due a minimum of three (3) weeks after your tournament. *Please arrange one payment to include all golfers. Harbor Golf cannot accommodate individual payments for organized tournaments.*

The credit card used to secure the deposit will be used to clear any outstanding amounts at the end of the tournament unless otherwise agreed upon.

CANCELLATION

Your tournament will proceed as scheduled, unless the course is deemed unplayable (eg: due to weather) by Harbor Golf Club. At this time, tournament green fees and cart costs will be refunded if a suitable delay is unattainable. The banquet portion (if applicable) will proceed regardless of inclement weather. Tournament cancellations occurring within less than 7 days of the Tournament date will forfeit FULL deposit and must pay 50% of tournament fee and banquet costs based on the “2 week out” numbers provided. Tournaments cancelled between 14 and 7 days of the Tournament will forfeit FULL deposit, however, rescheduling may be permitted within the same season without full loss of deposit.

LIABILITY

Your company / group via your tournament organizer, is responsible for any damage to the golf course, golf carts, rental clubs or clubhouse. Damages will be charged to the credit card on file. Harbor Golf Club assumes no responsibility for the loss of personal property.

Terms of Agreement

1. A non – refundable \$2000.00 deposit is required at the time of booking to ensure your tournament date. This deposit will be credited towards your final bill following the completion of your event. VIP Golf will require a 50% deposit based on the number of participants.
2. Tournaments cancelled within 14 days of the Tournament will forfeit FULL deposit.
3. Tournaments cancelled within 3 days must pay 50% of the tournament fee and banquet costs based on the latest number of golfers / diners provided.
4. An estimate of the number of golfers and banquet guests are required at the time of booking. Please confirm your final numbers for golfers two weeks prior to your tournament date. Additional golfers after that time are at the discretion of the Golf Operations Manager. You will be billed based on your one week out numbers or actual number of guests if they are higher than the guaranteed number.
5. If information regarding your tournament is not received in a timely manner, Harbor staff will set timelines, guidelines and organize accordingly.
6. The tournament organizer is responsible for any damage to the golf course, golf carts, rental clubs or clubhouse as well as for the providing safe transportation home for participants.
7. Harbor Golf Club assumes no responsibility for the loss of personal property.
8. Harbor Golf Club is licensed premises and therefore will be the sole supplier of food and beverage items. It is prohibited to bring personal alcoholic beverages onto the premises, including the parking lot. Any alcoholic beverages must be purchased from the clubhouse, the concession or the courtesy cart. Violators will be removed from the premises with no refund. **Organizers must stress this point to participants.** **It is illegal to consume cannabis in a public place. If Harbor Staff encounters a customer consuming cannabis, they are instructed to contact the RCMP for enforcement. **
9. By signing this agreement, you have read and agree to the Responsible Beverage Service statement in the 2025 Tournament Planning document and will reiterate to your guests prior to the event.
10. The tournament will proceed as scheduled, unless the course is deemed unplayable by Harbor Golf. At this point, tournament costs will be refunded. The meal portion of the event proceeds as scheduled.
11. Payment is due on the date of the event unless arrangements have been made to place on account. Any account past 30 days due are subject to 1.5% monthly interest. The credit card used for the deposit will be used to clear any outstanding amounts at the end of your tournament unless otherwise agreed upon.
