Harbor Golf Course was built in the late 80's by the provincial government. The course is located on provincial government land in the Harbour Recreational Site and is leased to shareholders. The RV Park was added in 2022. Enjoy panoramic views of the mighty Lake Diefenbaker, enjoy not only the golf course, but our full-service restaurant with a patio overlooking the marina.

CATERING POLICIES

Our Event Coordinator is committed to seeing that every detail is administered to your satisfaction. To ensure that your function runs smoothly, we request you acknowledge the following policies:



Contract & Deposit

All bookings or functions require a \$500 non-refundable deposit and signed contract upon agreement to book, to secure the function date and space. A credit card number is also required to be filled out on the signed contract or by calling Harbor Golf to secure the booking.

Cancellation Policy

All notices of cancellation must be received in writing for all events. Cancellations 45 days prior to the event date will forfeit their FULL deposit; 46 to 90 days prior to event date will forfeit 50% of their deposit; 91 or more days prior to the event will receive full refund on deposit.

Payments

All balances are due to be paid at the conclusion of your event unless arranged otherwise. We accept the following forms of payment; Credit Cards, Debit, Direct Deposit, E-Transfer or by sending you a pay link via Lightspeed Golf.

A 15% service charge, GST & PST are not included in the menu prices and will be added to your final bill. All alcoholic beverages are subject to 5% GST and 10% LCT which will also be added to your final bill.

Confirmation & Guarantee

A guaranteed number of guests must be confirmed 7 business days in advance for all bookings. Provision will be made for 5% more guests than expected, however, final charges will be based on the actual number attending or guaranteed, whichever is greater.

A more suitable function room may be assigned to your group should the numbers of guests or set-up requirements change. Room rental will be charged accordingly.

We will guarantee food and beverage pricing 30 days prior to the date of the function. Applicable service charges and taxes will apply.

Decorating & Musical Accompaniment

We will confirm room availability for decorating one week prior to the date of the function if required. Harbor Golf will not assume responsibility for any lost, stolen or damaged personal or rented items.

Your DJ/Band will be allowed to set up the day of your function. Entandam formally SOCAN (Society of Composers, Authors & Music Publishers of Canada) fees may apply. These are royalty fees which would be paid by the Club for all functions playing copyrighted music.

Outside Food & Beverage

No outside food or beverage is permitted on the premises except for Celebration Cakes, Wine and Champagne; beverages must be served by our staff and are subject to a corkage fee of \$11 per bottle. Remaining food and beverage from your function may not be removed from the premises with the exception of unopened or recorked wine or champagne.

Harbor Golf follows the Saskatchewan Liquor & Gaming Authority regulations. We reserve the right to refuse service to anyone who appears intoxicated. Your appointed Hosts are responsible for the conduct of your guests. Guests &/or organizers are encouraged to arrange transportation and designated drivers prior to the function.

Cancellation Policies

We will be more than happy to work with you to reschedule your event due to the ever-changing mandates and restrictions regarding public health emergencies. If the government guidelines at the time prohibit you from having your event or wedding, we will reschedule or refund your deposit in full.

Terms of Agreement

1. A \$500.00 deposit is required at the time of booking to ensure your event date. This deposit will be credited towards your final bill following the completion of your event.
2. Cancellations 45 days prior to the event date will forfeit their FULL deposit; 46 to 90 days prior to event date will forfeit 50% of their deposit; 91 or more days prior to the event will receive full refund on deposit.
3. An estimate of the number of guests is required at the time of booking. Please confirm your final numbers one week prior to your event date.
4. A guaranteed number of guests is required **seven (7) days** prior to the event. You will be billed based on your guaranteed numbers or actual number of guests if they are higher than the guaranteed number. *Payment is due on the date of the event unless arrangements have been made to place on account. Accounts past 30 days due are subject to a 1.5% monthly interest charge.*
5. A 15% gratuity charge on food service and host bar (if applicable), GST & PST are not included in the menu prices and will be added to your final bill.
6. Functions with bar service must end by 1:00 am with all guests vacated by 2:00 am.
7. Your event contact is responsible for any damage to the facility or event site.
8. Harbor Golf Club assumes no responsibility for the loss of personal property.
9. Harbor Golf Club will confirm prices one month prior to the event. Prices are subject to change until this point.
